I understand that my child's participation in activities and events is a privilege, and not a right. I acknowledge that I have spoken with my child about my child's need to comply with the specific rules and requirements established for such events and activities, rules of conduct set forth in the Volunteer Code of Conduct, and, state and federal regulations and laws.

I also understand that events and activities may expose my child to some risks and I assume any such risk that may arise there from. I accept full responsibility for all medical expenses for any injuries that might occur to my child by reason of his/her participation.

I authorize Youth for Troops to transport my minor child in a vehicle driven by an individual authorized by Youth for Troops. I understand my child is expected to follow all applicable laws regarding riding in a motor vehicle and is expected to follow the directions provided by the driver and/or volunteer. The owner of the vehicle must carry bodily injury insurance. Youth for Troops's insurance does not cover damages arising from, or related to, the operation of any private vehicle, failure to follow the directed driving route, or any personal negligence related to this activity. Any damages/harm resulting from a volunteer or other designated driver, arising from the operation of a motor vehicle in relation to the activities or events, is hereby waived.

***Initial Each Statement That Applies***

\_\_\_\_ I authorize the Board or volunteers of Youth for Troops to obtain medical/hospital treatment for the above participant in the event of an emergency.

\_\_\_\_ I give permission for my child to transport him/herself to and from activities and events.

\_\_\_\_ I give permission for my child to transport other minors to and from activities and events.

\_\_\_\_ I give permission for my child to ride in a vehicle to and from the activities or events with another minor.

\_\_\_\_ I give permission for my child to ride in a vehicle driven by an adult volunteer or parent of another minor to activities and events.

\_\_\_\_ As a condition for the transportation received, I, for myself, my child, my executors, and assigns, further agree to release and forever discharge Youth for Troops, and their agents, officers, and volunteers from any claim that I might have myself or that I could bring on my child's behalf with regard to any damages, demands, actions, complaints, suits or other forms of liability, including those based on negligence, in any manner arising out of transportation or participation. **By signing this form**, I hereby release Youth for Troops, its Board, its Board members, directors, volunteers, and agents from and against any and all claims, demands, actions, complaints, suits, or other forms of liability that any of them may sustain (a) arising out of my child's failure to comply with local, state, and federal laws and Youth for Troops policies and procedures, and the Code of Conduct; (b) arising out of any damage or injury caused by my child; or, (c) arising out of a parent/volunteer/or other designated driver's operation of a motor vehicle in relation to activities and events. I also agree to indemnify and hold harmless the released parties from the released claims, including any and all related costs, attorney fees, liabilities, settlements, and/or judgements.

\_\_\_\_ Photographs and video footage of participants for use in publications may be taken while participating in activities and events. I hereby give Youth for Troops permission to utilize photographs and video footage of the participant for the purpose of promoting and publicizing Youth for Troops, programs, events, and activities (including but not limited to their appearance in brochures, websites, and media releases). No personal information other than the participant's first name will be released under any circumstances, except as required by law.

This permission shall stay in effect until revoked in writing.

I also understand that I have the ability to refuse to sign this form. In addition, that if I refuse to sign, my child will not be permitted to participate in the activities and events.
